TERMS & CONDITIONS

These Terms & Conditions govern the provision of psychological services by Mind Health Associates Pty Ltd ABN 37 671 714 766 ("Mind Health", "we", "us") to clients ("you", "your"). By booking or attending appointments, you agree to these terms.

1. APPOINTMENTS & SERVICES

1.1 Session Duration: Standard consultations are 50 minutes. Extended sessions (90-120 minutes) available on request pending practitioner availability.

1.2 Service Delivery: Services provided face-to-face, via telehealth (video), or telephone at practitioner discretion.

1.3 Practitioner Allocation: We reserve the right to allocate or change practitioners based on availability and clinical suitability.

2. FEES & PAYMENT

2.1 Current Fees: Published at mindhealth.com.au/fees and subject to annual review.

2.2 Payment Terms: Initial consultations/assessments: Min. 50% non-refundable deposit required at booking. Balance due at appointment. Reports released only upon full payment. Accepted methods: Credit/debit card, EFTPOS, HICAPS, direct debit, cash (exact amount only)

2.3 Medicare/Insurance: Where eligible, we process claims on-the-spot. You remain responsible for gap payments and any rejected claim.

3. CANCELLATION & RESCHEDULING

3.1 Deposit Requirements: A minimum 50% non-refundable deposit is required to secure all appointments. This deposit is applied to your session fee upon attendance.

3.2 Notice Requirements

3.3 How to Calculate Notice: The 48-hour period is calculated from your exact appointment time. For example, if your appointment is at 2:00pm on Friday, you must cancel by 2:00pm on Wednesday. Monday appointments require notification by the preceding Friday 5:00pm.

3.4 Acceptable Cancellation Methods: Phone 1300 084 200 (Monday-Friday, 9:00am-5:00pm) — preferred. Email accepted as a written record. NOT accepted: Text/SMS, social media.

3.5 Payment of Cancellation Fees: Credit/debit cards on file will be automatically charged. Outstanding fees must be paid before future appointments can be scheduled. Medicare, private health funds, and third-party payers do not cover cancellation fees.

3.6 Emergencies: Genuine emergencies may be considered on a case-by-case basis: Sudden illness requiring medical attention (medical certificate required); Serious accidents (documentation required); Death in immediate family; Natural disasters.

3.7 Repeated Cancellations: Two (2) consecutive cancellations or frequent pattern may result in: Review of commitment to therapy; Service termination to allow access for other clients; Prepayment required for future appointments.

3.8 Pre-paid Sessions: Non-refundable but transferable with appropriate notice.

3.9 Group Programs: Require 7 days' notice. We reserve the right to modify/suspend groups. Clients may request refund or reschedule in such cases.

4. ATTENDANCE & CONDUCT: **4.1 Punctuality:** Arrivals >15 minutes late treated as no-show. Sessions not extended for late arrivals. **4.2 Zero Tolerance Policy:** We maintain a safe environment for all. The following result in immediate termination: Violence, threats, or aggressive behaviour; Harassment of staff or other clients; Discrimination or hate speech; Intoxication or substance impairment during sessions; Property Damage. **4.3 Repeated Non-Attendance:** Two (2) consecutive cancellations/no-shows may result in service termination.

5. CLINICAL POLICIES: **5.1 Consent:** You consent to assessment and treatment as recommended by your practitioner. **5.2 Confidentiality:** Subject to legal requirements including mandatory reporting obligations and court subpoenas. **5.3 Emergency Services:** We are not a crisis service. In emergencies call 000, Lifeline, or present to nearest hospital. **5.4 Communication:** Practitioners not available outside scheduled appointments. Non-urgent matters addressed at next session.

6. RECORDS & REPORTS: **6.1 Clinical Records:** Maintained per professional standards and privacy legislation. **6.2 Reports:** Completed within agreed timeframes after full payment. Complexity may affect delivery. **6.3 Access:** You may request access to your records subject to professional and legal limitations.

7. PRIVACY & DATA: **7.1 Collection:** We collect personal and health information necessary for service provision.; **7.2 Use:** Information used only for treatment, administration, and legal requirements. **7.3 Security:** Records stored securely with restricted access. **7.4 Full Policy:** mindhealth.com.au/privacy

8.
